**FOR A PERSON to REMOVE a VEHICLE, they MUST HAVE a VALID DRIVERS LICENSE ON THEM and PROOF of INSURANCE on the VEHICLE.**

**No transactions will occur without a copy of the vehicle registration or title and proper picture ID.**

**No vehicle will be driven out of the storage facility by a person without a VALID drivers license.**
