FOR A PERSON to REMOVE PROPERTY, they MUST HAVE PICTURE ID WITH THEM.
FOR A PERSON to REMOVE a VEHICLE, they MUST HAVE a VALID DRIVERS LICENSE ON THEM and PROOF of INSURANCE on the VEHICLE.
No transactions will occur without a copy of the vehicle registration or title and proper picture ID.
No vehicle will be driven out of the storage facility by a peson without a
VALID drivers license.
